ABOUT VIDHI AAGAZ

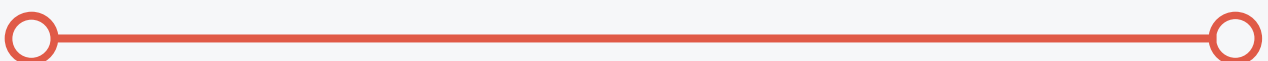

ABOUT ViACON 2018

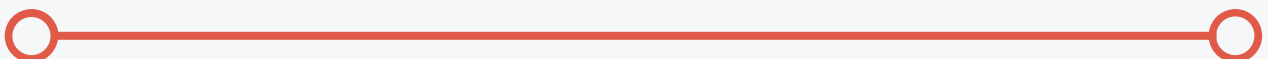

- Strengthening and expanding the human network of all involved in this field.

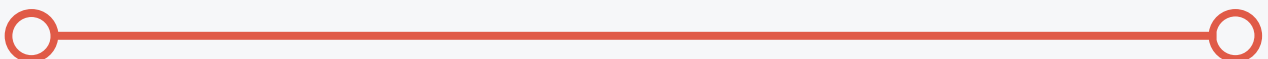

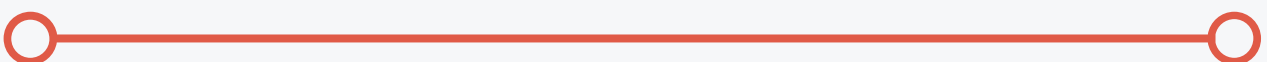
The main highlights of the ViACON: Chapter II are 3 prestigious awards to fight for:
